### **B. Steps to Apply for Empanelment: -**

1. Visit <https://www.pnbindia.in/>
2. Click on Tender and Empanelment and then FinTech Portal.

3. Register with basic details through sign up.
4. Default password and user id will be created.
5. Company to login with these credentials and change password.
6. Fill up the three forms namely- Company Credentials, Technical Expertise and Regulatory Adherence.
7. Attach supporting documents wherever required.
8. Submit the application.

**C. Process of Empanelment: -**

1. The FinTech empanelment through Bank's FinTech Portal which shall be made available and notice for the same shall also be given. (The Fintech portal window shall be made available for a period of 15 days).
2. The FinTechs shall register themselves and submit the desired documents on the Bank's FinTech Portal. A FinTech can register themselves in multiple domains also.
3. The FinTechs will be evaluated on the basis of the Selection Criteria for empanelment of Fintech & Eco-system partners. Clarifications, if required will be sought for.
4. During the evaluation, presentation may be sought from the Fintechs.
5. Once the Fintech are empanelled, they shall be provided with Letter of Empanelment.
6. Empanelled FinTech companies will submit a nominal fee of Rs.50,000 plus applicable GST which will be non-refundable and fee shall not be taken on re-empanelment of the FinTech/Ecosystem partner in same domain and also for empanelment in multiple domains.
7. Empanelled FinTech companies will execute empanelment agreement.
8. Upon receipt of empanelment fee and execution of empanelment agreement, the name of the FinTech will be displayed with FinTech Theme/Domain name on Bank's
